Production of Carry Bags and or MLP and or Sheets and or like etc

- Industry shall manufacture **Carry bags, sheet and plastic packaging** either be in **natural shade** or made using **only those pigments and colourants** which are in conformity with **Indian Standard : IS 9833:1981** (List of pigments and colourants for use in plastics in contact with foodstuffs, pharmaceuticals drinking water)
- Industry shall ensure that **Carry bag** made of virgin or recycled plastic, shall **not be less than fifty microns** in thickness;
- Industry shall manufacture **Plastic sheet or like**, which is not an integral part of multilayered packaging and cover made of plastic sheet used for packaging, wrapping the commodity shall **not be less than fifty microns** in thickness except where the thickness of such plastic sheets impair the functionality of the product;
- Industry shall ensure that Each plastic carry bag and multilayered packaging shall have the following information **printed in English** namely:-
 - Name, registration number** of the manufacturer and **thickness** in case of **carry bag**;
 - Name and registration number** of the manufacturer in case of multilayered packaging;
 - Name and certificate number** [Rule 4(h)] in case of carry bags made from compostable plastic

Industry shall ensure that Each **recycled carry bag** shall bear a label or a mark "**recycled**" as shown and shall conform to the Indian Standard: IS 14534: 1998.

6. Industry shall maintain a record of details of the person engaged in supply of plastic used as raw material to manufacture carry bags or plastic sheet or like or cover made of plastic sheet or multilayered packaging.
7. Industry shall maintain the complete records for back collection of plastic waste generated due to their products in market.
8. Industry shall submit **quarterly compliance report** regarding collection and disposal of plastic waste clearly indicating details of collection center, quantum of plastic waste collected & disposed off against EPR liability as per approved action plan (EPR) with all supporting documents.
9. Industry shall comply with the **manifest system** introduced by the Board (available on website) for the movement of the plastic waste within and from state of Gujarat and submit copy of prescribed manifest signed/ acknowledge by the all stakeholder with above referred quarterly compliance report.
10. Industry shall ensure that plastic waste is segregated properly and channelized to the recycler/co-processor/waste to oil manufacturer/others (specify) having valid CCA as well as registration under plastic rules.
11. Industry shall submit updated action plan for plastic waste management to the SPCB **while applying for Consent to Establish or Operate or Renewal, if any change in production of plastic products.**
12. Industry shall not Manufacture "**multi-layered plastic which is non-recyclable or non-energy recoverable or with no alternate use**"

Consumption of plastic sheets or like or covers made of plastic sheets or multi-layered packaging for packaging or wrapping the commodity

1. Industry shall ensure that Carry bags made of recycled plastic or products made of recycled plastic shall not be used for storing, carrying, dispensing or packaging ready to eat or drink food stuff;
2. Industry shall ensure that Each plastic carry bag and multilayered packaging shall have the following information **printed in English** namely,-
 - (a) **Name, registration number** of the manufacturer and **thickness** in case of **carry bag**;
 - (b) **Name and registration number** of the manufacturer in case of multilayered packaging;
 - (c) **Name and certificate number [Rule 4(h)]** in case of carry bags made from compostable plastic
3. Industry shall submit **quarterly compliance report** regarding collection and disposal of plastic waste clearly indicating details of collection center, quantum of plastic waste collected & disposed off against EPR liability as per approved action plan (EPR) with all supporting documents.
4. Industry shall comply with the **manifest system** introduced by the Board (available on website) for the movement of the plastic waste within and from state of Gujarat and submit copy of prescribed manifest signed/ acknowledge by the all stakeholder with above referred quarterly compliance report.
5. Industry shall ensure that plastic waste is segregated properly and channelized to the recycler/co-processor/waste to oil manufacturer/others (specify) having valid CCA as well as registration under plastic rules.
6. Industry shall submit updated action plan for plastic waste management to the SPCB **while applying for Consent to Establish or Operate or Renewal, if any change in usage or production of plastic products.**
7. Industry shall submit updated action plan for plastic waste management to the SPCB while applying for Consent to Establish or Operate or Renewal, if any change in usage/consumption of plastic products.
8. Industry shall not use/consume "**multi-layered plastic which is non-recyclable or non-energy recoverable or with no**



alternate use"

1. Unit shall manufacture Plastic Carry Bags for export purpose only and shall not sell in domestic market
2. Unit shall follow the marking or labeling procedure as per the rule 11 of The Plastic Waste Management Rules, 2016 within month and inform to this office without fail.
3. Industry shall submit **quarterly compliance report** regarding compliance of PWM rules.

General Conditions

1. Concealing factual data or submission of false/fabricated data may result in cancellation of registration and attract action under the provisions of Environment (Protection) Act, 1986.
2. The authority may revoke or suspend the approval, if implementation of any of the above condition is not satisfactory.
3. The authority reserve right to stipulate additional conditions if found necessary. The applicant in a bound manner shall implement these conditions.
4. Unit shall comply with conditions of CCA grant by this board.
